Keady Market would like to introduce a new schedule of fees this year.

**Early Bird Prime Package:** A one time fee of \$600.00, per lot, payable with a deposit of \$100.00 due March 1st, 2023, remainder due March 31st, 2023 includes attendance on any Tuesday for the entire 2023 year. Deadline to register for this package is March 1st, 2023

**Select Package:** A one time fee of \$500.00 (main street) or \$425.00 (side street) per lot, payable with a deposit of \$100.00 due March 1st, 2023, remainder due March 31st, 2023 includes attendance on any Tuesday from June 6th - Sept 12th, 2023. Deadline to register for this package is March 1st, 2023.

**Standard Package:** A fee of \$35.00 per lot will be charged each time a vendor attends on a weekly basis.

Any lots not paid in full by due date will result in cancellation of your reserved status. You may mail your payment (Post Dated Cheques, Canada Post Money Order or pay Cash) and a completed vendor agreement to Keady Livestock Market, 117012 Grey Road 3, R. Weekly vendors may obtain space any time after 4:30 am. There is no need to call ahead - first come first served. **All vendors should plan on being set up by 6:30 a.m. and remain in their lot until 2:00 p.m. Each vendor must have an agreement completed before entering the vendor lot. Please bring your completed information with you to avoid delays before parking. Print, complete and bring with you to obtain entry into the vendor lot. Please keep this letter for your records and complete the attached white copy of the Vendor Tenant Agreement and bring with you to be admitted to the vendor lot.**
